Senior level diplomatic engagement, worldwide political engagement with heads of states, ministers, members of parliament and senior civil servants.
- Since 2014 Political Commissioner of the Board of Directors (since 2015 as Chairman) of netzwerk-m e. V. (network-m) (www.netzwerk-m.de) and since 2017 of the AEM e. V.
